NARRATIVE	Narrative
	At approximately 0440 Hrs. on 05/09/2014 Telecommunicator Sheila Trull put out a call of shots fired at the Verizon Store at Town Center Loop. The suspect vehicle was a silver Toyota Tacoma. Earlier in the night Telecommunicator Sheila Trull had informed the squad that Lawrence Martin had been making threats about shooting up the Verizon Store and the Waynesville Police Department. The Haywood County Sheriff's Department had been relaying this information, because one of the Deputy's had been talking with Mr. Martin's son on the phone from New York. Mr. Martin lives up on Walker Rd.
	Sgt. Keith Moore was traveling South On South Main St. going to the call, when Sgt. Moore approached the red light at South Main St. and Hyatt Creek Rd. a silver Toyota Tacoma came through the intersection at a high rate of speed, this was the suspect vehicle in the shooting at Verizon. Sgt. Moore did a U-turn and initiated his blue lights and siren and attempted to stop the vehicle. The Toyota kept getting faster as the chase went North on South Main St., the Toyota kept crossing the center line and almost hit two vehicles head on on South Main St. The Toyota reached speeds of better than 85 mph on South Main St. As the vehicle approached the Waynesville Police Department Sgt. Moore advised Telecommunicator Sheila Trull to lock down the police department. The chase continued onto North Main St. When the Toyota entered the slight curve in front of the Haywood County Justice Center the driver lost control and hit a tree. Sgt. Moore, Officer Faulkenberry, and a Deputy approached the Toyota with caution and could see Mr. Martin laying in the front seat. Mr. Martin was extracted from the vehicle where he had been laying on the SKS rifle, there was a strong odor of alcohol coming from Mr. Martin. Sgt.

NARRATIVE
<p>Narrative</p> <p>On May 09, 2014 I was assigned as the on-call Investigator for the Waynesville Police Department. Dispatcher Sheila Trull told me there had been a shooting at the Verizon store on South Main Street. I had been requested to respond. Trull also informed me the suspect had led officers on a high speed pursuit through town, which resulted in a major traffic collision in which the suspect had been injured. I instructed Trull to notify Det. Vander Day so she could assist in the reconstruction investigation at the scene of the traffic collision. Det. Sgt. Trantham had also been notified and requested to respond</p> <p>I arrived at the Verizon Store located at 30 Town Center Loop at 0530 hrs. I walked through the parking lot and discovered several spent shell casings from a rifle. I made a mental note of the location and approached the store. I surveyed the front of the Verizon business and noticed numerous bullet holes through the glass. I could tell from looking through the adjacent windows that there was significant damage to the interior of the business but I could not tell exactly what had been hit by the projectiles. I requested Dispatcher Trull to contact the emergency contact for Verizon and have them respond to the scene. Officer Joey Fox arrived on scene to aid in securing it until we could properly process it for evidence. Officer Fox blocked off the entrances to the parking lot and posted himself at the location of the shell casings to secure them. I then left the Verizon location to go to the traffic collision scene to speak with Sgt. Moore.</p> <p>I met with Sgt. Moore and Lt. Tim O'Neill at the collision location. We discussed what had transpired and developed an action plan to ensure everything was being properly</p>

investigated and documented. It was determined that Sgt. Moore would be responsible for all of the related traffic charges as well as filing the Going Armed to the Terror of the People violation. A Haywood County Deputy had responded to the Hospital to stay with the suspect. Det. Vander Day was assigned to investigate the collision scene and Sgt. Trantham and I would go back to Verizon to complete the investigation. Lt. Oneill and I discussed notifying Capt. Beck and Chief Hollingsed about what had occurred and decided to notify them immediately.

I went back to the Verizon store to investigate. Sgt. Trantham and I met with R.J. Carter, the manager of the Verizon store to do a walk through of the business. Once inside we discovered the projectiles discharged from the rifle had resulted in significant damage. The projectiles had broken the glass in numerous locations and continued through the store into opposite side walls and beyond. At least two of the projectiles had passed through a large computer monitor which is attached to the Verizon computer system and shrapnel from other items struck had severely damaged another computer monitor which was also a component of the Verizon computer system. The decision was made not to attempt to recover all of the projectiles as that would have resulted in far greater damage being done. Sgt. Trantham and I photographed the scene to document the criminal damage caused by discharging the firearm into the public building. We also photographed the location of the shell casings to document their proximity to the Verizon building, which was directly in front of the business.

Sgt. Trantham and I collected the shell casings and numbered them 1 through 14. The shell casings have been logged into evidence. We met with Manger R.J. Carter again and informed him to tell us if any further damage was discovered and to give us an estimate of damage as soon as possible.
